The Bidder shall furnish documentary evidence to demonstrate that it meets the following experience requirement(s): (i) Must have successfully completed at least one (1) contract having a value of ETB 120,000,000.00 (One Hundred Twenty Million Birr) or two (2) contracts each with the Minimum value of ETB 80,000,000(Eighty Million Birr) for Lot I and , one (1) contract having a value of ETB 80,000,000.00 (Eighty Million Birr) or two (2) contracts each with the Minimum value of ETB 40,000,000(Forty Million Birr) for each of lot II and III , with a similar size, nature and complexity during the last 5 (Five Years) supported with the names of the clients, types and value of the contract, (ii) The bidder shall demonstrate that it has access to, or has available liquid assets, unencumbered real assets, lines of credit and other financial means (independent of any contractual advance payment) sufficient to meet the cash flow requirement of ETB 30,000,000 (Thirty Million Birr) for lot I , and ETB 20,000,000 (Twenty Million Birr) for each of lot II and III (iii) The audited Financial Statement or, other financial statement acceptable to the Employer for the last five Years shall be submitted and must demonstrate the current soundness of the bidder's financial position and indicate its prospective long term profitability, and (iv) Minimum Average Annual Turnover of ETB 220,000,000 (Two Hundred Twenty Million) for Lot I , and ETB 150,000,000 (One Hundred Fifty Million Birr) for each of Lot II and II, calculated as average of total certified payments received for contracts in Progress and/or completed within the last five years.

Bidding will be conducted through the National Competitive Bidding procedures as specified in the World Bank Procurement Regulations for IPF Borrowers Procurement in investment project financing, Goods, Works, Non-Consulting and Consulting Service, fifth edition September 2023, and is open to all eligible bidders as defined in the Procurement Regulations. In addition, please refer to paragraphs 1.6 and 1.7 setting forth the World Bank's policy on conflict of interest.
