All bids shall be accompanied by a Bid Security of ETB 50,000 (Fifty Thousand) in the form of Unconditional Bank Guarantee or CPO to Ministry of Water and Energy, and shall remain valid for 118 (One Hundred eighteen) days. For Bank Guarantee the bidder must use the bank guarantee form included in section IV (Bid Form) of the bidding Document.
- 7. The dead line for bid submission shall be in February 28, 2024 at 2:00 PM and opened on the same day, February 28, 2024 at 2:30 PM in the presence of bidders' representatives.
